Announcements:

ISSS Scholarship for International Students on an F-1 Visa

The International Student and Scholar Services (ISSS) Scholarship recognizes campus and community engagement among international students and scholars from a diverse set of cultures. Scholarship recipients represent outstanding contributors who may have extenuating circumstances that require financial need, and yet have strong academic performance and make time to participate in the community with a goal of serving others and promoting engagement in co-curricular activities during their time at the University of Utah. Each scholarship is valued as a total of **\$4,000** and will be applied as **a tuition waiver of \$2,000 for the Fall and \$2,000 for Spring semester of the academic year 2021-2022**. Tax Reminder!

All International students & scholars who lived in the U.S. in 2020 must file taxes by **April 15, 2021**.

ISSS is partnering with a service called [Sprintax](#) to assist non-residents for tax purposes in preparing their federal and state tax filings online. If you use Sprintax, we are offering an access code to help offset the cost of filing. Sprintax access codes will be available beginning **February 8, 2021**.

Travel

ISSS does not recommend traveling outside of the U.S. at this time, since we are unable to predict how current travel restrictions may change in the future. Please continue to check the [COVID-19 FAQ](#) page on the ISSS website for updates as they become available. We do not know how long [COVID-19 travel restrictions](#) will last and what additional countries may be added or removed from the restrictions already in place. Both current travel restrictions and visa processing delays at U.S. consulates, for students who need a new F-1 visa, might make it impossible for some students to enter the U.S. and return to campus.

If you are reentering the U.S. please be aware of [travel guidance](#) domestically or internationally at this time. ***Any travel you choose to do during this time is at your own risk.*** Due to COVID-19, U.S. Customs and Border Patrol as well as USCIS are allowing the use of digitally signed forms of I-20s.

If you need a travel signature, you can complete the E-form “*I-20 reprint request*” in UAtlas and we will process a signed *electronic* copy of your I-20. Once the I-20 has been processed you will be able to access the completed document in your UAtlas portal. You will need to **print** your I-20, and complete the “Student Attestation” section of the I-20 for it to be valid.

As a reminder, travel signatures are valid for 1 year for enrolled students, and 6 months for those on OPT or STEM OPT.

On January 20th, President Biden issued a Presidential Proclamation revoking Travel Bans 4.0 and 3.0 which restricted travel from Iran, Syria, Yemen, Libya, Somalia, Nigeria, Venezuela, Myanmar, Eritrea, Kyrgyzstan, Sudan, North Korea, and Tanzania.
